Dear Parents and Guardians,

Re: Strict Enforcement of Sri KL Traffic Regulations Beginning Second Semester 2025

Please be informed, starting 16th June 2025, the School will be launching an enforcement campaign targeting drivers in and around the school compound who are in breach of the traffic regulations.

In order to do this, we have set up a new team dedicated to issuing warnings to errant drivers via a **Red Notice** attached to the windscreen of their vehicles, a copy of which is attached for your easy reference.

In particular, drivers are now reminded to strictly observe the following existing rules which apply to parents as well as their drivers, third-party pick-up services and other family members without exception:

CAR STICKERS & COLOUR CODED CARDS

- All vehicles wishing to enter the school compound before 4.30PM must display a **current registered Sri KL car sticker AND the relevant colour-coded card that applies to your child.**
- Our enforcement team will be checking all vehicles prior to entry and drivers of vehicles without either one of the above items will be issued a Red Notice.

VEHICLES ARRIVING EARLY FOR PICK-UP

- You are reminded to arrive not earlier than 10 minutes before your child's scheduled pick-up time.
- Vehicles arriving early will be asked to move on. Failure to comply will result in a Red Notice being issued.

VEHICLES WAITING ANYWHERE NEAR THE SCHOOL COMPOUND BEFORE 2.50PM (MON - THU) and 12.20PM (FRI)

- From Monday to Thursday, any vehicle found waiting on Persiaran Kewajipan, the Kewajipan roundabout or the entry road leading to the Kewajipan roundabout before 2.50PM will be directed to move on.
- On Friday, vehicles are reminded not to start queuing before 12.20PM.
- Drivers who do not comply with instructions will be issued a Red Notice.

BOOKSHOP, UNIFORM SHOP & ADMIN OFFICE VISITS

- From Monday to Friday, all visitors to the Bookshop, the Uniform Shop and the Admin Counter are strongly advised to visit from 9.00AM – 12.00PM.
- Visitors will be directed to park outside the school compound for a maximum of 1 hour only. After this time you will be instructed to move your vehicle.
- Drivers who do not comply will be issued a Red Notice

DISCIPLINARY ACTION THAT WILL BE TAKEN AGAINST ERRANT DRIVERS

- **Offending vehicles that are issued a Red Notice will be banned from entry until all traffic regulation requirements are met.**
- **This applies to all vehicles whether registered with the School or unregistered.**
- **Kindly note, unregistered vehicles will be tracked to ascertain the identity of students being picked up and action will be taken against those students.**
- **First-time offenders will receive a warning and 2 demerit points.**
- **Second-time offenders will receive additional demerit points and their children will be suspended from school for ONE WEEK with no appeal allowed.**
- **Repeat offenders will have their child's enrolment at Sri KL immediately terminated with no appeal allowed and no refund of fees.**

If you are currently unaware of the Traffic Regulations as they apply to Sri KL drivers, kindly refer to the attached copies of previous notices to parents. If you need further assistance, please call or email the School's Admin Office during normal school hours.

Lastly, we strongly recommend all parents to brief drivers and other family members on the need to strictly follow the traffic regulations and what the consequences will be for those who breach these regulations.

If you are waiting to pick up a student/students from Sri KL, you are in breach of Rule 6.11 of the School's Traffic Regulations. Specifically,

(A) Entering/Waiting/Parking/Queuing in zone of control before correct time	(F) Cutting queue
(B) Waiting/Parking/Queuing incorrectly in zone of control before correct time	(G) Dangerous driving
(C) Leaving vehicle unattended in zone of control	(H) Unregistered vehicle in zone of control
(D) Causing nuisance to other road users	(J) Failure to follow instructions of authorized personnel
(E) Destroying/Disposing of warning notice whilst in zone of control	(K) Failure to display coloured card

You are hereby given notice, not to repeat this action. Failure to comply will result in the suspension of the student/students being collected. If you are a registered user of the School's traffic app, then you will be informed online and the appropriate number of demerit points will be deducted from your account.

If you are unregistered, then the students concerned will be informed by the school directly.

IMPORTANT NOTICE: REPEAT INFRINGEMENTS WILL RESULT IN EXTENDED SUSPENSION AND MAY LEAD TO EXPULSION OF THE STUDENT/S CONCERNED FROM SCHOOL.

Failure to follow the Traffic Laws of Malaysia/Local Authority Traffic By-Laws/Directions from RELA personnel make you liable to fines, wheel clamping and/or prosecution in a court of law
